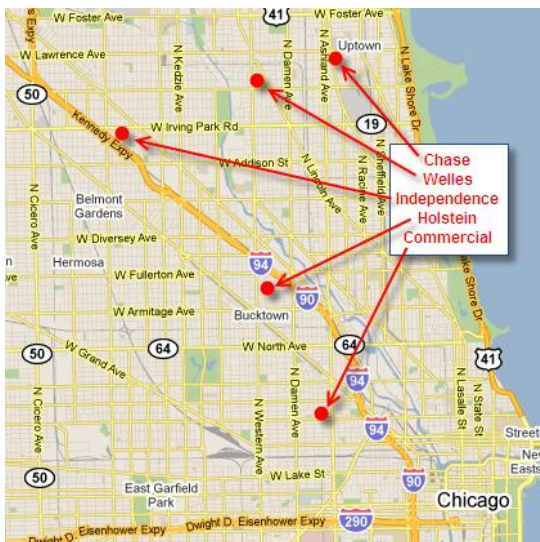

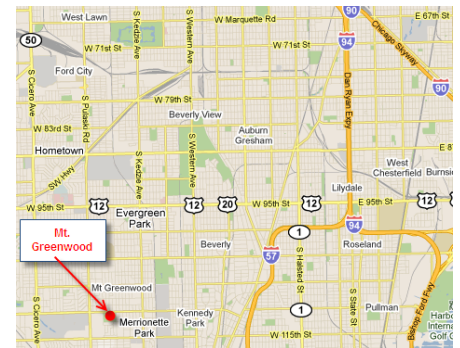

Every October for the past 15 years, The Midnight Circus has set up for a month of free programming in the heart of downtown Chicago with the city's famous skyline as the backdrop. Since 2007, The Midnight Circus has partnered with The Chicago Park District to perform a series of daytime shows in several of the city's parks to raise money to help rebuild the parks and their playgrounds.

The Midnight Circus is an eclectic company of actors and acrobats, aerialists and eccentrics, clowns and contortionists, singers, dancers, musicians and a dog who appeal to all ages. They provide the audience with music, merriment and a dose of delightful entertainment in a natural urban setting in your park. 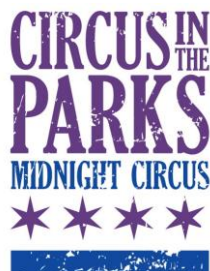
